TRAINER BOROUGH - ENGINEER'S REPORT

Buckley Cable – 9th Street and Price Street Improvements

Buckley has reached out to determine if they are allowed to proceed with the parking lot project. I have asked for the balance of their escrow account to determine if it needs to be replenished for inspections. The applicant needs to provide signed and sealed drawings for issuance of a permit.

Monroe Energy

PennDOT has required Monroe to revise proposal for two separate driveways to incorporate access into modification of the existing driveway. We reviewed the DCCD letter regarding the proposed Propane dispensing facility. NO CHANGE

Post Road

PennDOT advised they have been backed-up with work and will respond with a schedule for patching the roadway areas. We will inform Council upon their input.

MS4 Program

We are preparing the annual report which is due September 30th.

Erosion Ridge Road

We developed options for restoring the embankment and forwarded a detail for a segmental block retaining to Moore Outdoor Rejuvenation based on our collaboration with them. Work in the area of the exposed utility line(s) will need to be completed in accordance with PECO requirements. A new uniform height 6" asphalt berm should be installed as soon as possible where the berm is missing or deficient in height to avoid additional wash out. This was not included on the quotation provided of \$17,600 for construction of a 4' high segmental block wall. I notified them and they replied they will go to the site tomorrow to provide a quote for the installation of the asphalt berm. The temporarily closing of the parking areas above the eroded areas shall be maintained until the embankment area is restored.

Adelphia Cable Pipeline

Adelphia Cable submitted ACT 14 notifications for pipeline construction in June. The project still requires an agreement with the Borough for use the property behind the church.

Parkview Project

The Sketch Plan has been provided in electronic and paper format for discussion of how their Land Development and Subdivision Application should proceed, seek variances or provide for ordinance changes that would negate the need for variances.
